

Bronco[®] Gold Equine Fly Spray has been especially developed for use on horses. It provides a protective hair coating against flies while imparting a high sheen to the hair when brushed out. 1-2 ounces per head per day gives adequate protection. Apply by either soft cloth or fine mist spray.

USE TO WIPE ON: First, brush animal to remove excess dirt and dust. Moisten (but do not wet to the point of dripping) a soft cloth and rub over the hair. It is best to apply by rubbing against the hair growth. Give special attention to the legs, shoulders, shanks, neck and facial areas where files most often are seen.
